CORAZÓN TEQUILA AND LOS VECINOS MEZCAL NAMED CHAIRMAN’S TROPHY FINALISTS AT 2020 ULTIMATE SPIRITS CHALLENGE

LOUISVILLE, KY (Sept. 1, 2020) – Ten of the Sazerac Company’s Corazón and Los Vecinos agave brands were recognized at the 2020 Ultimate Spirits Challenge, and two were named finalists for the highest award bestowed by the competition. Corazón de Agave Añejo Tequila and Los Vecinos del Campo Ensamble No. 1 Mezcal were the Chairman’s Trophy Finalists.
